To the People of Oklahoma:

I am pleased to issue the August monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

Geopolitical concerns during August continued to affect the flight to quality and the consistent demand for Treasuries. The 5-year Treasury ended the month at 1.62% which reflected a 0.037% reduction in yield. The yield on the 10-year Treasury declined almost 25 basis points to the lowest level since June 2013. The 30-year began the month at 3.28% but fell to 3.08% by month's end. The Federal Open Market Committee continued to taper and acknowledged improvement in the economy, but reiterated their patience in preserving the current policy stance.

The S&P Index ended at 2,003 and gained 3.8% for the month. The index also crossed the 2,000 point milestone earlier in the month. The Dow Jones Industrial Average closed at 17,098 earning 3.2% in August and the NASDAQ came in at 4,082 and finished 4.8% higher.

Economic Developments

There were 209,000 net new jobs created in July, as reported by the Labor Department. The unemployment rate edged up slightly to 6.2%. The industries having the strongest hiring were professional and business services, as well as manufacturing and construction.

The Consumer Price Index (CPI), which measures changes in prices that U.S. consumers pay for goods and services throughout the country, rose 0.1% in July. Core CPI increased 0.1% month-over-month leaving its year-over-year reading 1.9% higher. Food prices rose 0.4% month-over-month and energy prices decreased 0.3% during the month. Producer prices increased one-tenth of a percentage point in July and were higher by 1.7% over the trailing twelve months.

Retail sales were unchanged in July, with core sales up only 0.1% and June sales being revised downward by 0.1%. Sales declined in autos, furniture, electronics, department stores and internet retailers. The ISM Manufacturing Index increased in July to a reading of 57.1 from 55.3 in June, which marked the highest reading since April 2011.

The Census Bureau reported the seasonally adjusted annualized housing starts at 1.093 million units, its highest reading since last November and reflected a 21% increase from a year earlier. Building starts grew 8% for single-family and 28% for multi-family units. Existing home sales of single-family homes rose 2.7% while multi-family units were flat month-over-month.

The Commerce Department reported its second estimate of the Gross Domestic Product (GDP), which indicated a two-tenths upward revision to 4.2% quarter-over-quarter growth in the second quarter of 2014. The U.S. Trade Deficit decreased 7% month-over-month to \$41.5B for June. The decline was attributed to the lowest petroleum import figure in three years. Exports increased one-tenth of a percentage point to a record of \$195.9B.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.83% in August and the weighted average maturity was 977 days. The year-to-date monthly average investable base was \$4.13 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 43% of the portfolio. Mortgage-backed securities were 40%, municipal bonds were 1% and Certificates of Deposit represented 3% of assets. Money market mutual funds and commercial paper sweep were 6%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and the current low interest rate environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$4,088,834,784 and State Agency balances in OK Invest at \$2,423,433,786 for a total of \$6,512,268,570.



In February 2014, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2015. The amount estimated was \$73,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

August 31, 2014

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securitiet Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$290.21. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
