To the People of Oklahoma:

I am pleased to issue the January monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

Treasury yields slumped during the month, with the 2-year note reflecting the largest monthly decrease since January 2010. The 2-year Treasury ended at 0.77%, dwindling 27 basis points over the month. The 10-year began January yielding 2.27% finishing at a low of 1.92%, reflecting the largest monthly loss in a year. The 30-year Treasury ended the month at 2.74%.

The stock market posted the worst January performance since 2009. The S&P 500 index closed at 1,940 losing 5.1% for the month. The Dow Jones Industrial Average came in at 16,466 and lost 5.5%, along with the Nasdaq Composite ending at 4,613 sliding 7.9% for the month. The performance of the Nasdaq reflected its worst month since May 2010. January's stock market losses were blamed on the Fed's interest rate increase the previous month, disappointing fourth quarter U.S. growth, lingering low oil prices and worries about company earnings.

Interest rates were unchanged by the Fed, with minutes from the December meeting reflecting continuing concerns about an unrelenting low inflation outlook. They also stated that policy normalization would gradually occur and would be data dependent. There was also apprehension in regard to the squashing effect on the economy of a strong U.S. dollar and lethargic overseas growth. The meeting was the first for four new members of the Federal Open Market Committee.

Economic Developments

The unemployment rate ended 2015 at 5% compared to 5.7% at the beginning of the year. December's non-farm payrolls were 275,000 which were higher than anticipated. There were upward revisions to non-farm payrolls in October and November to 312,000 and 240,000, respectively. The labor participation rate increased slightly from 62.5% to 62.6% and underemployment remained stagnant at 9.9%.

The core consumer price index (CPI), which excludes food and energy costs, increased 0.1% in December after going up 0.2% for the last three months. In 2015 the core CPI increased 2.1%. According to the Bureau of Labor Statistics, the producer price index (PPI) for final demand decreased a seasonally adjusted 0.2% in December. Final demand prices increased 0.3% in November and fell 0.4% in October. The Institute for Supply Management (ISM) manufacturing index was reported at 48, a reading above 50 indicates expanding factory activity. New orders, production, employment and raw materials inventories were attributed to the month-over-month contraction.

Retail sales for December decreased 0.1% and November headline retail sales were upwardly revised from 2% to 4%. Taking out automobile sales, November sales were adjusted to an increase of 0.3% from the previously reported 0.4%. Retail sales were up 2.8% on a year-over-year basis, and increased 2% year-over-year when

automobile sales were excluded. Retail sales in 2015 were brisk in areas such as auto-related, non-store retailer, furniture and eating and drinking establishments. Automakers reported approximately 17.5 million cars and trucks in annual sales, in comparison to 10.4 million in 2009 when tax payers bailed out the industry. The 2015 sales were an estimated \$437 billion which surpassed a six-year growth streak, the industry's first since World War II. The increase in automobile sales was attributed to improving wages, consumer confidence in a stronger job market, easy credit and low gas prices.

The National Association of Realtors reported there were 5.26 million of existing home sales in 2015, which was the highest in annual existing home sales since 2006. The median existing-home price for all housing types was \$224,100, up 7.6% from December 2014. Total housing inventory decreased 12.3% to 1.79 million and was 3.8% lower than a year ago. Unsold inventory was at a 3.9-month supply, down from 5.1 months in November and the lowest since January 2005.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.81% in January and the weighted average maturity was 939 days. The year-to-date monthly average investable base was \$3.73 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 44% of the portfolio. Mortgage-backed securities were 40%, municipal bonds were 2% and Certificates of Deposit represented 3% of assets. Money market mutual funds were 5% and OK Invest, which is comprised of various State agency funds, represented 3% of the total portfolio. State Bond Issues (at 1%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and the current low interest rate environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,675,802,336 and State Agency balances in OK Invest at \$2,389,464,575 for a total of \$6,065,266,911.

In December 2014, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2016. The amount estimated was \$53,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

January 31, 2016

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securities Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$2,231.94. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
