## OKLAHOMA STATE TREASURER

September 20, 2016

To the People of Oklahoma:

I am pleased to issue the July monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

### Market Conditions

Investors continued to be uneasy surrounding the United Kingdom's exit from the European Union and the dovish posture of central banks across the world, which increased safe investments and pumped up prices in the Treasuries market. Yields decreased the largest amount during the month since February, with the benchmark 10-year Treasury ending July at 1.45%. The 2-year came in at .65% and the 30-year at 2.18%, which reflected a 10 basis point yield drop from the first of the month, the spread between the 10-year and 2 year Treasury was 0.80%.

The stock markets recovered somewhat during the month from the unexpected outcome of the Brexit vote. The S&P 500 came in at 2,173 and Nasdaq posted 4,730, both ending at new 52-week highs. The Dow Jones Industrial Average finished July at 18,432.

The Federal Reserve Open Market Committee decided the interest rate policy range should stay at 0.25%-0.50% and they would continue to evaluate inflation and international markets. The Kansas City Fed president, Esther George, voted against the non-action and was the only dissenter. Ms. George indicated her preference would be a quarter-point increase, even though she supported the Committee's decision in June to not increase rates.

### Economic Developments

The unemployment rate was reported as rising from 4.7% to 4.9% in June and the underemployment rate decreased from 9.7% to 9.6%. The labor participation rate rose from 62.2% to 62.7%. In addition, the Labor Department reported that 287,000 jobs were added in June, but revised the May nonfarm payroll projection from 38,000 to a scanty 11,000 jobs. Recent volatility in the nonfarm payroll data was attributed to labor strikes, especially in the telecommunications industry. Average hourly earnings increased by 0.1% in June and 2.6% year-over-year.

The consumer price index (CPI) reflected an increase in June of 0.2%, with a gain in energy prices being attributed to growth. When food and energy were excluded, the CPI grew by 0.2% and reflected year-over-year expansion by 1.0%. The producer price index (PPI) is up year-over-year by 0.3% and by 0.5% for the month. PPI also increased by 0.4%, when volatile components were removed. According to the Bureau of Labor Statistics, the PPI report reflected the final demand for goods was very strong and increased to the highest level seen since May 2015.

The Commerce Department reported that retail sales grew to a seasonally adjusted 0.6%, from an increase of 0.2% in May. Sales were up 2.7% from a year earlier. Building materials and gardening supply purchases jumped 3.9% and accounted for approximately 42% of the total increase in June sales. Online retailers increased sales by 1.1%, but sales at apparel stores decreased by 1%. The largest retail segment, auto dealers, had puny growth of 0.1% and purchases of trucks and new cars did not meet expected projections for June.

The National Association of Realtors reported that total housing inventory at the end of June fell 0.9% to 2.12 million existing homes available for sale and represented a 5.8% decrease from a year ago. First-time home buyers came in at 33%, which was up from 30% in May and was the highest since July 2012. The median existing-home price for all housing types was \$247,700, up 4.8% from June 2015.

The second quarter gross domestic product (GDP) was reported by the Commerce Department to be a paltry 1.2% and the first quarter was revised lower from 1.1% to 0.8%. The GDP, which is the broadest measure of goods and services produced across the U.S., came in lower than expected and raised new concerns in regard to economic recovery.

#### Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.80% in July and the weighted average maturity was 757 days. The year-to-date monthly average investable base was \$3.15 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 39% of the portfolio. Mortgage-backed securities were 39%, municipal bonds were 2% and Certificates of Deposit represented 4% of assets. Money market mutual funds were 9% and OK Invest, which is comprised of various State agency funds, represented 3% of the total portfolio. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and the current low interest rate environment.

#### Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

#### Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

#### Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,144,125,845 and State Agency balances in OK Invest at \$2,290,958,039 for a total of \$5,435,083,884.

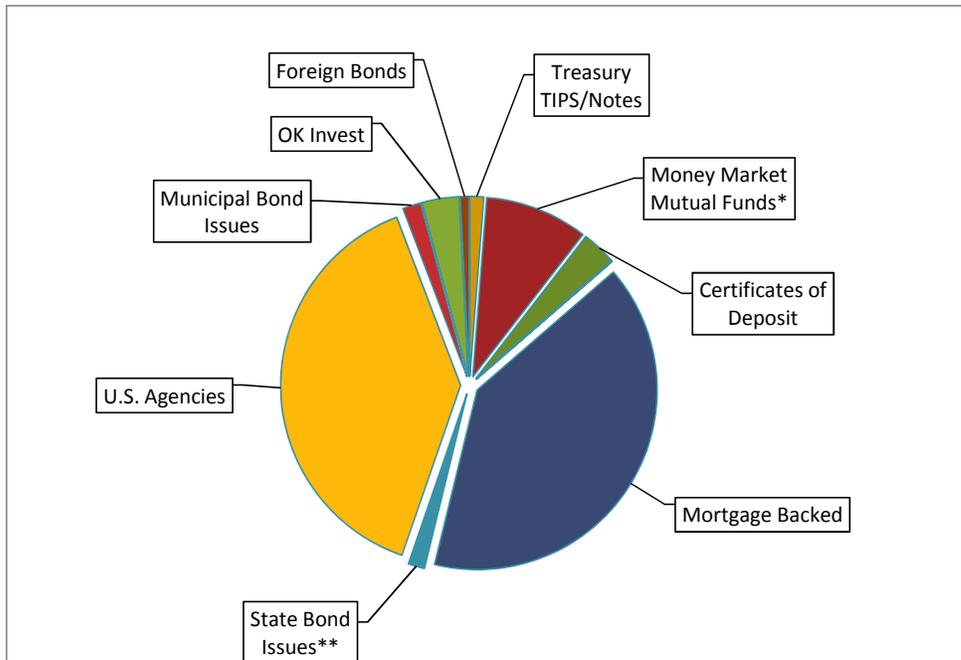

# Explanation of Performance Comparison

## July 31, 2016

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at Northern Trust Company.



**NOTE:** Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securities Lending Program with Northern Trust Company acting as lending agent. Northern retains 15% of the revenues generated as compensation for services. Its share for the month was \$0.00. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
