To the People of Oklahoma:

I am pleased to issue the November monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

Treasury prices soared sending 10-year yields to the lowest in more than five weeks, at the end of November. The 10-year Treasury benchmark began the month at 2.34% then slid to a yield of 2.16%. The 30-year reached a high of 3.10%, but finished at 2.89%. Investors continued to gravitate to Treasuries given the yield advantage over relative foreign safe-haven alternatives and the climbing Dollar.

The Dow Jones Industrial Average ended November at 17,828, the S&P 500 Index came in at 2,067 and the tech-rich Nasdaq Composite Index increased to 4,791. The Dow, S&P and Nasdaq increased in November by 2.52%, 2.45% and 3.47% respectively.

The Federal Open Market Committee meeting minutes from October reiterated the Fed still does not intend to deploy a time-tabled approach to changing the rate policy, but is still focusing on a data dependent strategy.

Economic Developments

The Bureau of Labor Statistics reported the October unemployment rate decreased to a seasonally adjusted 5.8% from 5.9% in September. Job gains for U.S. non-farm employers was 214,000 on a seasonally adjusted basis, which represented the ninth consecutive month in which job gains had surpassed 200,000. In comparison to October 2013 the number of people who held part-time jobs, but who were looking for full-time employment, was down by 989,000.

The core Consumer Price Index (CPI), ex-food and energy, expanded 0.2% month-over-month and stood 1.8% higher year-over-year. Gas prices dropped 3% in October and were down approximately 5% year-over-year. Prices for food grew only 0.1% month-over-month, the smallest increase since June. The Producer Price Index (PPI) rose by 0.2% month-over-month. Prices of goods fell 0.4%, while prices for services rose 0.5% for the month.

October retail sales reflected a seasonally adjusted gain of 0.3%, in comparison to -0.3% for the previous month. Retail sales rose 4.1% over the past year, with the largest gains being reflected in sporting goods/hobbies, apparel, building materials and restaurant/bars. Electronics/appliance retailers and department stores experienced a drop in sales.

Existing home sales increased to an annualized pace of 5.26 million, the most since 2003, as reported by the National Association of Realtors (NAR). It was also announced by NAR that for the 12-month period ending June 2014, only 33% of home sales were to first-time buyers. The percentage reflected the lowest participation of first-time home buyers in nearly thirty years. The Commerce Department reported the revised seasonally adjusted third-quarter Gross Domestic Product (GDP) increased to an annualized rate of 3.9%, from the first estimate of 3.5%. The GDP is the broadest measure of goods and service produced across the U.S. economy.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.80% in November and the weighted average maturity was 1,051 days. The year-to-date monthly average investable base was \$4.19 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 43% of the portfolio. Mortgage-backed securities were 39%, municipal bonds were 1% and Certificates of Deposit represented 3% of assets. Money market mutual funds and commercial paper sweep were 7%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and the current low interest rate environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$4,057,919,403 and State Agency balances in OK Invest at \$2,623,756,293 for a total of \$6,681,675,696.



In February 2014, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2015. The amount estimated was \$73,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

November 30, 2014

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securities Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$2,149.42. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
