## OKLAHOMA STATE TREASURER

December 17, 2013

To the People of Oklahoma:

I am pleased to issue the October monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

### Market Conditions

In October 5-year U.S. Treasury notes ended at 1.33%, 10-year Treasuries fell from a high of 2.73% to 2.55% and the 30-year bond yield was at 3.64%. The Dow Jones Industrial Average finished the month at 15,545. The broad-based S&P 500 declined slightly to 1,756, while the Nasdaq Composite Index came in at 3,919. During the month of October, the Dow gained 2.8%, the Nasdaq was up 3.9% and the S&P 500 advanced 4.5%.

From October 1 - 16 there was a partial U.S. government shutdown due to the Congressional battle over the budget and the debt ceiling. The debt ceiling was extended to February 7, 2014 reopening the government until January 15, 2014. The temporary budget extension allows Congress additional time to address tax reform and long-term deficit reduction plans. On October 30, the Federal Reserve maintained its aggressive monetary stimulus policy in a widely expected decision. Janet Yellen was nominated to be the next Federal Open Market Committee Chair to succeed Bernanke, whose term expires on January 31, 2014.

### Economic Developments

The Labor Department reported the unemployment rate for September slipped 1/10<sup>th</sup> of a point to 7.2%, which was the lowest jobless rate since November 2008. There was still much concern that the unemployment rate continued to fall primarily due to a shrinking labor force rather than robust job creation. The labor force participation rate was unchanged at 63.2%, which matched its lowest level since August 1978.

Private-sector payrolls were led by gains in construction, wholesale trade and transportation and warehousing. Construction added 20,000 jobs in September after six months of stagnation. Retail industries added 20,800 jobs, largely at food and beverage stores and automobile dealers, but that was a slower pace than August's gain of nearly 32,000. Jobs in the leisure and hospitality industry fell by 13,000 jobs. Government jobs rose by 22,000 with increases at state and local governments offsetting declines from the federal sector. Economist said rebounding tax revenues likely contributed to the rise in state and local government hiring.

The headline consumer price index (CPI) rose 0.2% in September as expected. Core CPI, less food and energy costs, rose a softer 0.1%. The producer prices index (PPI) was not released due to the partial government shutdown.

Retail Sales in September, excluding automobiles, increased by 0.4%. The release of two new iPhone models in late September accounted for most of the increase in electronic sales during the month. Total retail sales were forecasted to remain flat, but instead declined by 0.1%. The decline was attributed to a decrease in the

purchase of automobiles, which fell by the most since October 2012. Fewer weekend selling days and constrained supply, after strong August sales, likely caused a decrease in purchases of automobiles.

The National Association of Realtors released its September monthly report, which reflected that pending home sales of previously owned homes fell 5.6% on a seasonally adjusted basis. Pending home sales stood 1.1% above its year-ago level and marked a noticeable softening in the housing sector. The drop from a year ago reflects the first time in more than two years that pending home sales were lower than they were a year earlier. The Realtors group attributed the drop to rising costs of purchasing a home, as well as budget battles in Congress that diminished consumers' confidence.

The Commerce Department reported that the U.S. trade deficit widened in August from July by 0.4% to \$38.8B. The small change on a month-over-month basis was attributed to a 0.1% drop in exports. Export decreases were due to a 5.7% reduction in the volume of petroleum products, despite being up 32% on a year-over-year basis. The importing of petroleum products has experienced a 9.3% decline and there has been a slight tick downwards for imports of autos and consumer goods. Import prices rose in September for a second consecutive month, as reported by the Labor Department. Import prices increased 0.2% and August's level was increased to 0.2% after originally being flat. Export prices climbed 0.3% in September after falling the prior six months in a row.

#### Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.82% in October and the weighted average maturity was 1,135 days. The year-to-date monthly average investable base was \$4.126 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 40% of the portfolio. Mortgage-backed securities were 37%, municipal bonds were 2% and Certificates of Deposit represented 2% of assets. Money market mutual funds were 12%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

#### Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

#### Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

#### Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$4,331,738,200 and State Agency balances in OK Invest at \$2,381,303,220 for a total of \$6,713,041,420.



In February 2013, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2014. The amount estimated was \$86,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

## **Explanation of Performance Comparison October 31, 2013**

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



**NOTE:** Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider.

An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securitiet Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$2,974.31. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
